* The duties for the examination and publishing for the application for an industrial permit, a small-scale production permit, a small-scale beer producer's permit, a cooperative of small-scale producers or a warehouse permit are indexed on April 1st of each year according to the percentage change in the All-items Consumer Price Index for Canada, for the preceding year.

* These duties are non-refundable.

** A payable duty of \$ 147 must be added to the examination and publishing duties, if the applicant requires a temporary authorization to operate an existing producer's permit.
